



CLUB BY-LAWS

These are the **By-Laws** of Morris Car Club (Victoria) Inc. which have been **written** and **accepted** by the Management and Ordinary committee of Morris Car Club (Victoria) Inc. in which all **current financial members** of Morris Car Club (Victoria) Inc. **must** abide. These By-Laws are **effective** from the date of Tuesday 5th May 2015.

1. STATEMENT OF PURPOSE

The **aims** and **objectives** of Morris Car Club (Victoria) Inc. are to provide the ideal place for all to **socialize** and **participate** in Morris Car Club (Victoria) Inc. organised functions.¹

Morris Car Club (Victoria) Inc. is **open** to all that are interested in but **not limited only** to motor vehicles built by Morris, BMC, British Leyland and Leyland Australia marqueses but **all** motor vehicles that fit under the terms of:

Veteran (Manufactured before 31 December 1918)

Vintage (Manufactured after 1 January 1919 and before 31 December 1930)

Classic and Historic (Manufactured after 1 January 1931 and is more than 25 years old).

2. CONSTITUTION

All Morris Car Club (Victoria) Members must **comply** with the rules and regulations of the **Model Rules for an Incorporated Association** under the **Association Incorporation Reform Act 2012** which has been set out by **Consumer Affairs Victoria** and that Morris Car Club (Victoria) Inc. has **agreed** to abide by.

3. CLUB PERMIT SCHEME

All Morris Car Club (Victoria) Inc. members with Club Permit Scheme vehicles must **comply** with Morris Car Club (Victoria) Inc. **Club Permit Scheme Code of Practice** which was made **effective** from January 31st 2015.

4. MEMBERSHIP ATTENDANCE

All members that **attend** Morris Car Club (Victoria) Inc. functions must **sign** the attendance sheet at the Morris Car Club (Victoria) Inc. function.¹

5. LIFE MEMBERSHIP

(1) Morris Car Club (Victoria) Inc. Life Membership may be **awarded** by the Management Committee of Morris Car Club (Victoria) Inc. in accordance with the following **guidelines**:

(1.A) The Morris Car Club (Victoria) Inc. member must have been a **continuously financial member** for **no less than (10) years**.

(1.B) The Morris Car Club (Victoria) Inc. member **must** have (in the opinion of the Management Committee) provided **exemplary service** to Morris Car Club (Victoria) Inc. over a prolonged period and have actively **promoted** the **aims** and **objectives** of Morris Car Club (Victoria) Inc.

(1.C) **Sitting members** of the Management and Ordinary Committee of Morris Car Club (Victoria) Inc. at the time of the proposal are **not eligible**.

(2) A Life member of Morris Car Club (Victoria) Inc. has all of the **rights** and **privileges** associated with **ordinary membership** of Morris Car Club (Victoria) Inc. but is **exempt** from the requirement to pay the **annual subscription fee**.

6. PERPETUAL TROPHIES

(1.A) MARGRET JOHNSON COMMEMORATIVE TROPHY

AWARDED TO: Best Morris Car Club (Victoria) Inc. Vehicle

CHOSEN BY: Ladies Choice (Ladies in Attendance at Show & Shine)

PRESENTED AT: Morris Car Club (Victoria) Inc. Show & Shine and/or Christmas Party

(1.B) MOLINA FAMILY TROPHY

AWARDED TO: Most Outstanding and/or Deserving Morris Car Club (Victoria) Inc. Member

CHOSEN BY: Previous Year's Winner and Management and Ordinary Committee

PRESENTED AT: Morris Car Club (Victoria) Inc. Show & Shine and/or Christmas Party

(2) Both the Margret Johnston Commemorative and Molina Family perpetual trophies must be **returned** to the committee of Morris Car Club (Victoria) Inc. by **no later** than the **October Monthly General Meeting**.

(3) A **replacement trophy** will be provided by Morris Car Club (Victoria) Inc. for both the Margret Johnston Commemorative and Molina Family trophies and will be presented to the **previous year's winner** at the Morris Car Club (Victoria) Inc. Annual Show & Shine and Christmas Party.

7. COMMITTEE POSITIONS

The Morris Car Club (Victoria) Inc. Committee **consists** of a *Management Committee* and an *Ordinary Committee* which are **elected** at the Morris Car Club (Victoria) Inc. Annual General Meeting which is **held** in April of each year.

Club By-Laws* or the *Morris Car Club (Victoria) Inc. Club Permit Scheme Code of Practice* or the *Morris Car Club (Victoria) Inc. Privacy Policy* may face **disciplinary action** under the **Model Rules for an Incorporated Association**.

(1.A) If a Morris Car Club (Victoria) Inc. member **continues** to breach any of the above **policies** after facing **disciplinary action** they may face **expulsion** from Morris Car Club (Victoria) Inc.
