New Club show-n-shine structure

As discussed at the last meeting and in general discussion over the past couple of months, the club is putting a more robust structure around the annual show-n-shine.

What is driving the need for a structure

The existing approach has several issues including:

- There is no real continuity in terms of approach and outcomes from one year to the next.
- Members are not clear about how decisions are being made in relation to their car.
- All categories have recently morphed into a popularity contest without structure or clarity.
- Left unchecked, our ability as a club to encourage larger numbers of entries would be diminished

Traditionally show-n-shine events are used by car clubs to present a forum for members to showcase their cars. There will always be a large discrepancy between the winners against the average entry; not all people enter to win but simply to share. The winners do, however, present the best possible of examples that can showcase and attract more people to our brands.

Popular vote alongside judged results

Usually a show-n-shine event has winners in a number of categories that are assessed by experienced and informed scrutineers.

To select placegetters and winners there is a need for a framework against which points are allocated or removed. A set approach increases the consistency of the judging year on year.

The input of the broader membership is catered for through an overall "most popular" vote where every member is invited to select their favourite.

It is not the intent of the suggested approach to make our show-n-shine a 'concours' event, far from it. The approach is largely based on common sense but by adopting it we will:

- Give clarity to every entrant and club member about how a vehicle will be judged.
- Remove any ambiguity around what matters.
- Allow members to make informed decisions about whether they want to address specific issues that may reduce or increase their vehicle's score.
- Provide a showcase for all members to present their vehicle.

Comments and suggestions

After hearing some of the comments from the floor during the meeting, I think we need broader guidance for those cars that fall into the 'modified' categories. If people have suggestions on how the suggested format could be broadened for modified vehicles please send these to me so I can review and possibly amend the suggested approach.



Judging guidelines for entrants in the Club's Annual Show-n-shine

Introduction



Judging

The make-up of the judging panel will be one committee member, and two visitors (preferably from another car club that know British cars). The results will be based on a maximum of 100 points. Points will be based on **Exterior, Interior, Engine Bay** and the vehicle's **Overall Presence** (see outline below).

Judging for the *Most Popular Vehicle* will be by a secret ballot with all club members being given one vote each to place against any entry present on the day. The judges will tally the results and include the announcement with the other winners on the day.

Each entrant will begin with a total of 90 points. Judges will assess whether the entrant exceeds, meets or falls short of the judging criteria.

Should a judge feel that the vehicle's state does not completely align with the statement, they need to decide whether the variation is:

- Minor deduct 1 point
- Moderate deduct 3 points
- Major deduct 5 points

The exception to the above point system is the fourth category 'Overall Presence'. Judges can elect to allocate back up to 10 additional points for areas where they perceive the sum of the parts of a vehicle's restoration and or preservation to be worthy of acknowledgement outside of the three main categories. Overall Presence is akin to an 'X' factor.

There are four categories that a vehicle can be entered in for judging for the annual Show-n-shine. formal judging categories will include:

Exterior – state of bright-work (chrome), state of paint and presentation (well-polished and preserved).

A maximum of 30 points

Interior – state and quality of interior presentation including, seating, door-cards, roof lining, carpets and any features standard or fitted.

A maximum of 30 points

Engine Bay – state and cleanliness of the engine and engine bay, condition of essential operating equipment, hoses, fanbelts, battery.

A maximum of 30 points

Overall presence – the presence will factor how the sum of the above categories combine to make a vehicle stand-out of a crowd.

A maximum of 10 points



Trophies will be awarded for the categories and sections outlined below:

- Best 2-door
- Best 4-door (including Woodies)
- Best Commercial (Utes, trucks and non-domestic vans)

Criteria to determine which section a vehicle falls into:

1. Standard

a. A like copy of the original – new paint, seatbelts, interior recovering, installation of heating and use of BMC or Leyland brake boosters of all brands will be accepted in the 'Standard category'.

2. Partly modified

- a. Upgrades and changes that alter the look and operation of the vehicle, including;
- b. Addition of a new powertrain (e.g. Datsun 120Y/1200 engine, gearbox and diff), different/modified wheels, body panels and or;
- c. Modern fittings e.g. bucket seats or modified seats from a newer vehicle, disc brakes, power-boosted brakes will place vehicles in this category.

3. Fully modified

a. Where primarily the only remaining artefact from the original production vehicle is a donor body.

Cars that have had off-the-shelf upgrades using Morris/BMC parts, will not be considered as modified. As these tuning up-grades were available from the dealer at the time of the cars manufacture – e.g. twin or larger single carburetor/s and or a sports exhaust system. If partly modified, e.g. a Datsun 120Y motor and transmission, all components need to be fitted neatly and safely.
